FURTHER DELAY IN DESPATCH OF CIRCULAR

The Company announces that, as additional time is required to finalise the content of the Circular, the despatch of the Circular will be further postponed from 29 June 2012 to on or before 31 July 2012.

Reference is made to the announcement (the “**First Announcement**”) of the Company dated 15 March 2012 in respect of the acquisition of 75% of the issued share capital of ETC Technology Limited, the announcement (the “**Second Announcement**”) of the Company dated 27 April 2012 and the announcement (the “**Third Announcement**”) of the Company dated 31 May 2012 in relation to the delay in despatch of the circular.
